THROUGH ANNUAL DISTRIBUTIONS FROM ITS INVESTMENT PORTFOLIO, THE FOUNDATION FINANCIALLY SUPPORTS ORGANIZATIONAL OPERATIONS, FACILITIES AND CRITICAL PROGRAMS LIKE CAMP FIRE MINNESOTA'S AFTERSCHOOL AND INCLASS ENVIRONMENTAL EDUCATION, ENVIRONMENTAL EDUCATION FIELD TRIPS, AND CAMP PROGRAMS.
